Instruction - Our experienced staff and camp director, Jason Stokes, 2008 Tampa Bay Buccaneers Coach of the Year, will emphasize fundamentals, form and technique as our program is a **NON-CONTACT CAMP**. There will be no pads worn. Campers will be grouped according to age, size and ability so that they can compete against campers of similar talents. Each camper will work on both offense and defense. Our camper to Coach ratios is 15 to 1 so that each camper will receive individual one on one instruction in the areas of passing, receiving, running, blocking, and tackling. Because football is a team game, each camper will also be required to run several drills in a group type of situation, so an individual learns to operate within the team concept. Along with the basic football skills, each camper will also be professionally trained and tested in the areas of speed, strength and agility. This will allow them to maximize their overall athletic ability.

Campers will need: Only football cleats. PLEASE leave your own footballs at home. The camp will supply footballs. This is a non-contact camp so no pads will be needed or worn. Come dressed appropriately. Bring one bag with you as there will be a place to store it. Please note that “The Kellen Winslow Jr. Camp” accepts no responsibility for lost or stolen items.

The road from the playground to the pros is often lined with stories of hardship and perseverance against the odds. But sometimes the biggest test comes from the appearance of opportunity. Kellen Winslow, Jr. has been challenged to emerge from the shadow of greatness cast by his Hall-of-Fame father, San Diego

Charger Kellen Winslow. As a new addition to the Tampa Bay Buccaneers, it is obvious the younger Winslow has met the challenge full-on and will forge his own individual and illustrious path through the NFL.

Regarded as one of the most impressive tight ends to ever play for the famed Miami Hurricanes, Kellen Winslow, Jr. was picked 6th overall by the Cleveland Browns in the 2004 NFL Draft. In 2003, he was an All-American first-team selection and awarded the John Mackey Award as the nation's premier tight end. His 119 receptions place him fifth on the University of Miami's career-record list and mark the most ever for a Hurricanes tight end.

**WAIVER AND RELEASE OF LIABILITY,
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

WAIVER: In consideration for being allowed to participate in the **Kellen Winslow, Jr. Football Camp on June 19-21, 2009** (the "Event") I, for myself, my heirs, family, personal representatives and/or assigns, do hereby release, waive, discharge and agree not-to-sue the National Football League, its member professional football teams including the Tampa Bay Buccaneers, Buccaneers Limited Partnership, Tampa Bay Broadcasting, Inc., Buccaneers Football Stadium Limited Partnership, Buccaneers Stadium Corporation, First Allied Development Partners and all of their respective partners, stockholders, officers, directors, employees, agents, affiliates and sponsors, from all present and future claims for property damage, personal injury, or wrongful death arising as a result of my participation in the Event on **June 19-21, 2009** resulting from any cause, including the ordinary negligence of the parties listed above, wherever, whenever, or however the same may occur.
